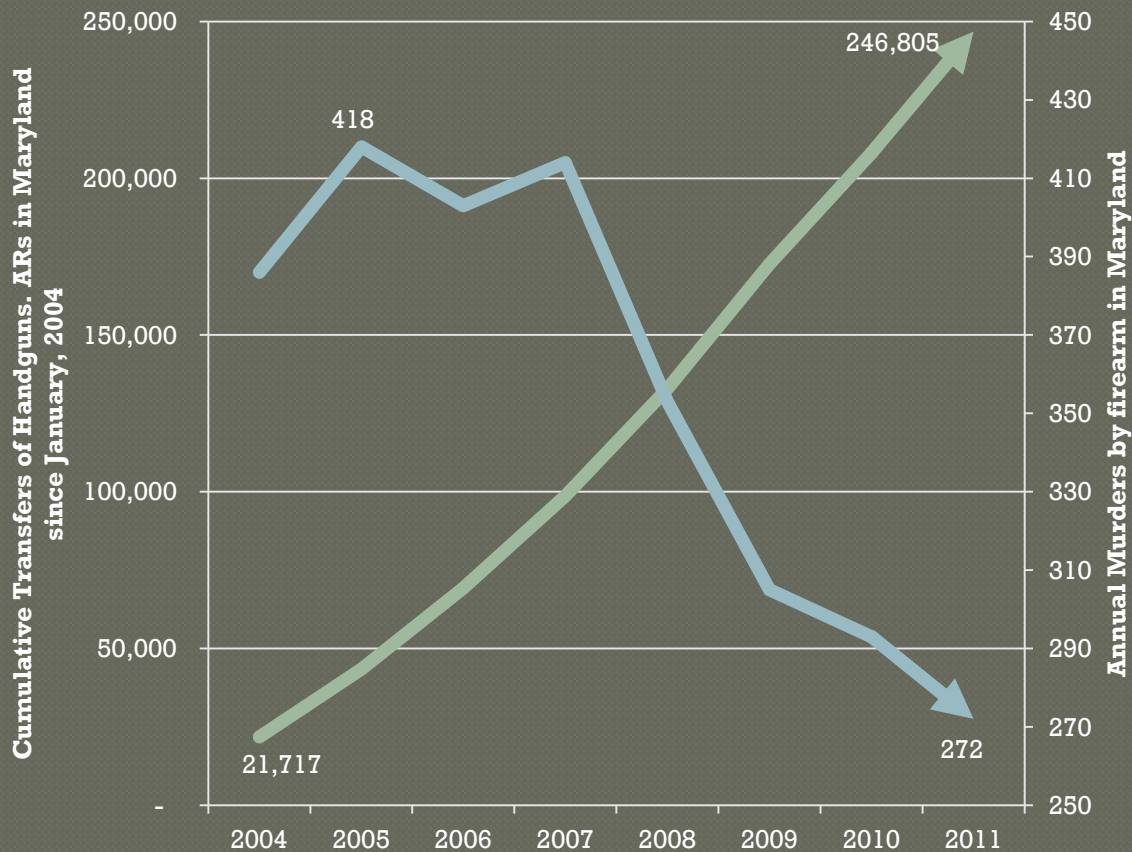

What about the Missouri study on handgun permits?

- In fact, Webster and colleagues admit these limitations!

“First, the cross-sectional study design precludes an assessment of whether changes in gun control laws prompt subsequent changes in crime gun exports. Longitudinal crime gun trace data could not be obtained, as many of the state laws of interest were in place before crime gun tracing become common practice.... Second, our outcome data does not include all crime gun exports. Not all crime guns are submitted to the ATF for tracing. In 2009, gun traces could not be completed for nearly 40% of crime guns due to insufficient or incorrect data. Third, *although reducing the diversion of guns to criminals is a key objective of some gun control laws, there is currently insufficient research to discern the degree to which reductions in diverted guns affects gun violence, and it appears as though some have had no impact.*” [emphasis added]

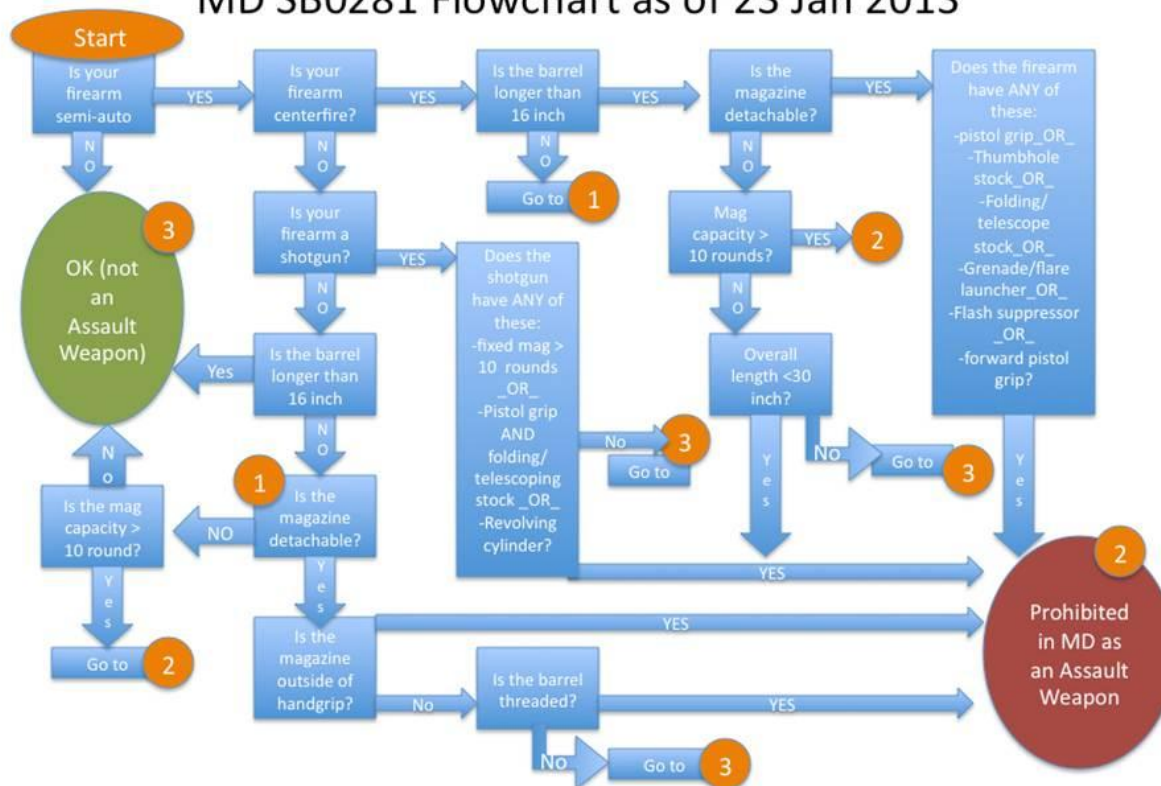

Tortured ‘12-point’ test is a confusing morass

(with a mandatory 3-yr. prison term attached if you get it wrong)

*Detachable = AMMUNITION FEEDING DEVICE THAT CAN BE REMOVED READILY FROM A FIREARM WITHOUT REQUIRING DISASSEMBLY OF THE FIREARM ACTION OR WITHOUT THE USE OF A TOOL, INCLUDING A BULLET OR CARTRIDGE.

The Folly of Copy Cat 'Features Test'



Based upon SB281/HB294 before any amendments

All are *same* model rifle with the same functionally

- Same semi-auto action, centerfire ammunition, detachable magazines, rate of fire, etc.
- Same potential lethality/utility for hunting, defense purposes
- Superficially different stocks, handles, accessories, “vibes”

Estimated Md-regulated “assault weapons” in private hands at close of 2013.

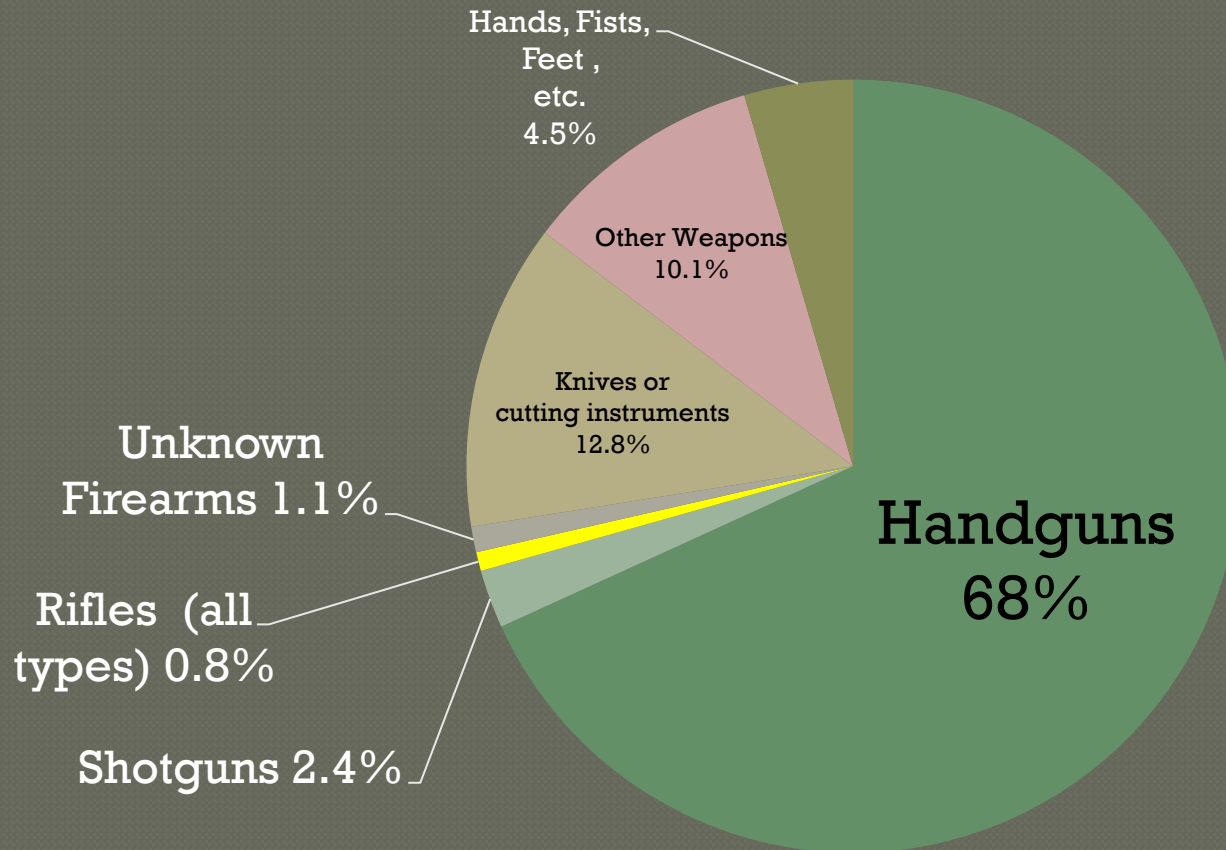
Maryland State Police: **Approx. 46,900**

Under vastly expanded definitions and after 11 months of panic-buying in response to ban threat?

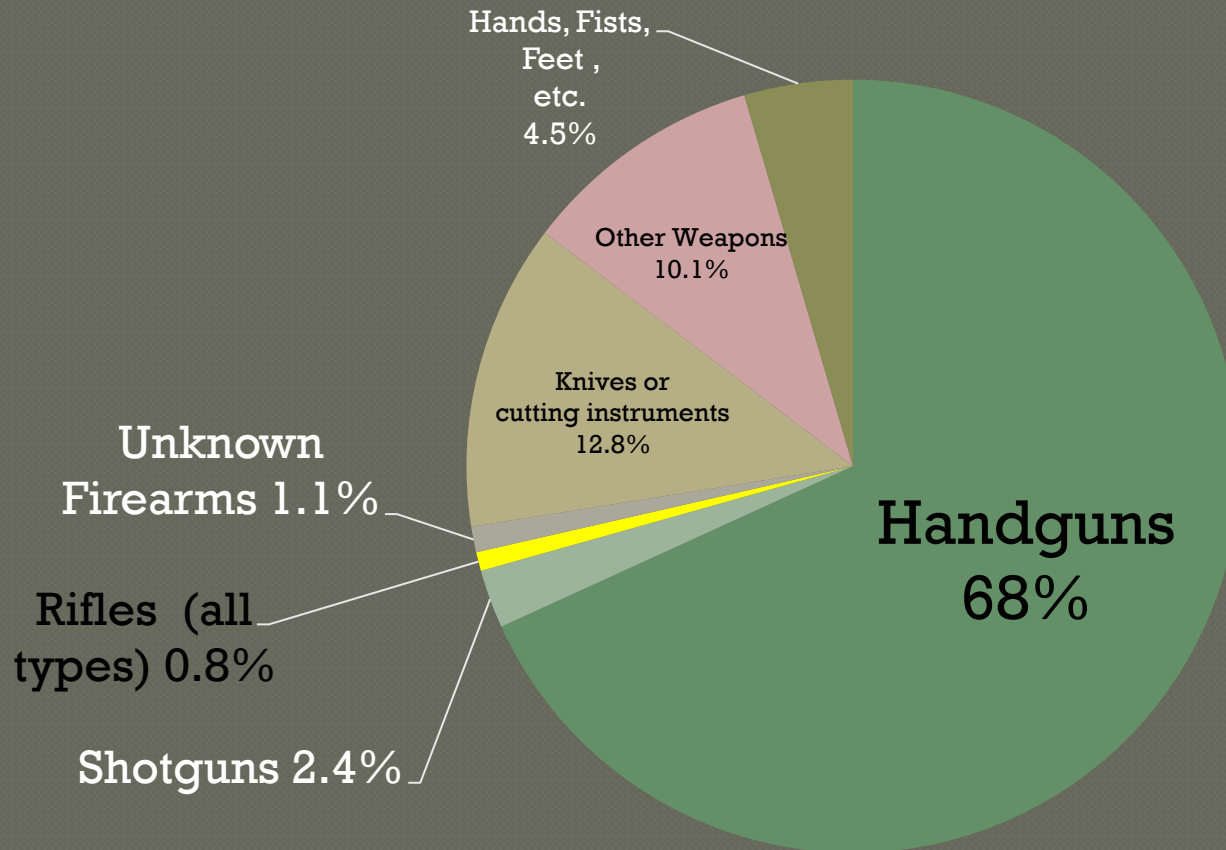
Maryland Murders by Instrument, '04-'11

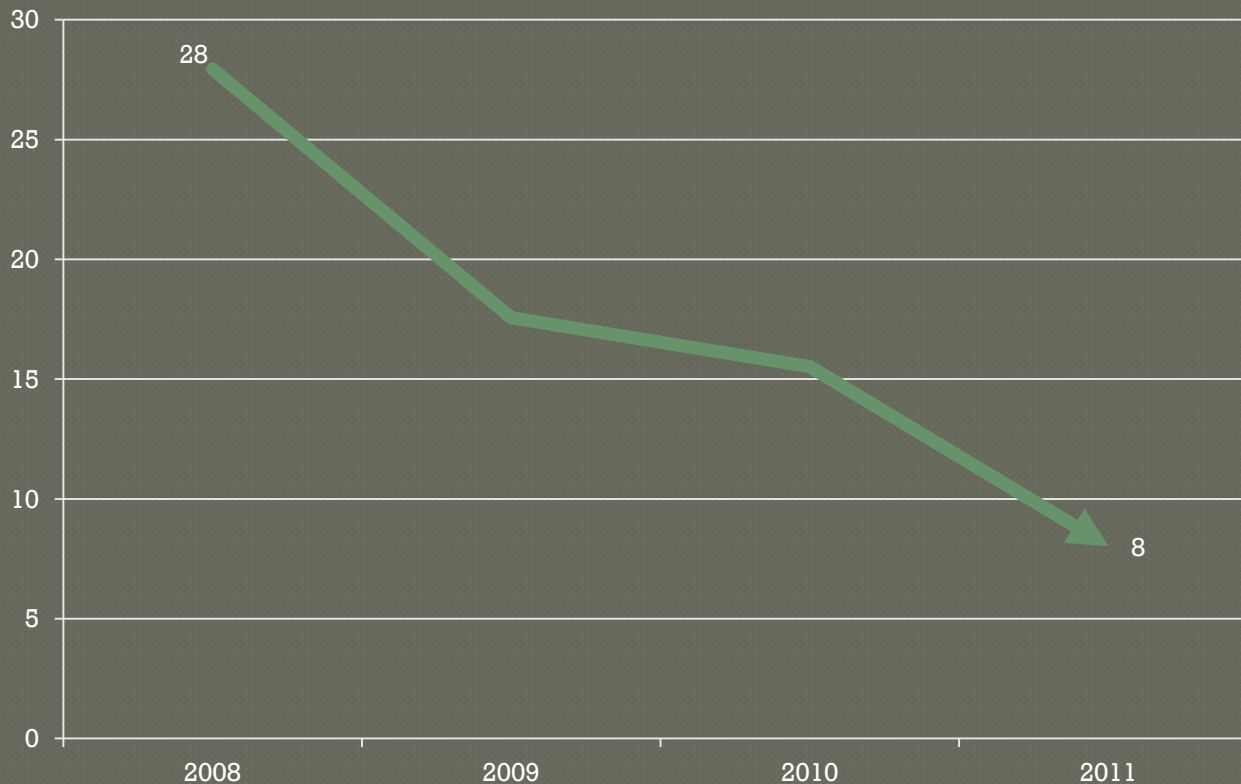

Conclusion

The governor's gun control package is a solution to a problem Maryland doesn't have (rifles)—and promises no solution to the problem Maryland does (concentrated urban violence from repeat offenders with illegal handguns).

Gun bans, fingerprinting and licensing punish only the law-abiding; and they deceive the public with scientifically baseless claims of gains in safety.
