

## SCHOOL INCIDENTS

Police in Kennesaw, GA arrested Kenneth Glover a student at Kennesaw State University after finding a loaded handgun in his backpack. Police confronted Glover after he told a school psychologist that he wanted to shoot people and identified himself as Jesus Christ. Glover was found sitting on a wall outside of the school dining hall and appeared to be mentally unstable. He is currently undergoing mental evaluation.



27 year old David Dipasquale of Athens, GA has been charged with making social media threats of school violence. It's alleged that Dipasquale posted comments on "Whisper" that were superimposed over a photograph of Sandy Hook Elementary School. Dipasquale commented "The only question is how many kids are going to die" and "Suicide by cop is the best way to go." His Whisper username was "futureschoolshooter." Whisper does not require users to provide personal information, although they provided police an IP address which led to Dipasquale.



A 12 year old student at the North Scott Junior High School in Elkridge, IA has been charged with bringing a .22 caliber handgun onto school property. The 12 year old pulled the gun out in a classroom and pointed it at the face of a fellow student. He pulled the trigger, but luckily the pistol safety was engaged and it did not fire. The student was disarmed by a teacher. He has been charged with attempted murder and a firearms violation.

A 17 year old student at Automotive High School in Brooklyn, NY has been charged with stabbing a fellow student with a metal pick comb. The student was stabbed in the hand, back, neck and the top of his head and was treated at a local hospital for his injuries. The cause of the incident is unknown.

Citing that 65 youths and young adults had been charged in Macomb County, MI, with making threats against schools following the Parkland, FL school shooting, Judge Carl Marlinga sentenced Jacob Graham to one year in jail to be followed by five years probation for making a social media threat. Judge Marlinga called Graham's attorney's claims that the incident where he threatened Chippewa Valley High School a "stupid joke or dumb mistake" as offensive. Judge Marlinga stated "I'm not going to accept any references to minimize this by calling it a stupid joke."



Leslie Delaney, a cafeteria worker at Norwalk High School in Norwalk, CT has been arrested for telling a fellow employee that he was planning on coming to school with a gun. Delaney is alleged to have said if the employee ever saw dressed in army fatigues, they should leave because he would have an AK-47 that he would use to finish everything and then "off" himself. During a search of Delaney's vehicle, police recovered an unloaded .22 caliber rifle. He has been charged with making threats and possession of a firearm on school property.

A 12 year old student at East Union Middle School in Marshville, NC was found with a .380 caliber handgun in his possession. School administrators received information that the student had displayed the weapon to other students. The school resource officer confronted the student and recovered the handgun and a set of metallic knuckles. He has been charged as a juvenile for having a gun on school property and faces disciplinary action by the school system.

A Buchholz High School student in Gainesville, FL has been arrested for bringing a gun to school and threatening another student. The 16 year old girl engaged another student and pulled out the gun and said "I outta kill you." When confronted by the school resource officer, the girl became combative and had to be physically restrained. The student has been charged with bringing the weapon onto school property, assault and resisting arrest.



An 18 year old student at Northwestern High School in Rock Hill, NC has been charged with bringing a loaded handgun to school. School authorities were alerted to the student and the school resource officer recovered the weapon in the student's book bag. The student, Tony Lopez, has been charged as an adult with bringing the 9mm pistol onto school property.

Fidel Medina, 29, was arrested for attempting to enter the Cherokee High School in Evesham, NJ. Medina was observed trying to enter the school through a locked vestibule. When confronted, Medina claimed to be picking up a student. The name given by Medina was not the name of any student or employee at the school. When taken into custody, police found he possessed a Taser stun gun, pepper spray and a length of rope in his car. This is the second time Medina has been charged with trespassing at the school. He is currently undergoing a mental evaluation.



Students at the Rise Up Academy in South Bend, IN alerted school authorities that a student had brought a gun to school. The 17 year old student was confronted by authorities and a handgun was recovered. The student has been charged for bringing the gun to school and faces disciplinary charges.

Officials in Gwinnett County, GA are releasing few details other than to say a Parkview High School student has been charged with bringing a gun to school. Administrators were tipped off by other students. Security officers located the student and recovered the gun. The student has been charged with having a gun on school property.

---

A 17 year old student at South Iredell High School in Troutman, NC has been arrested for bringing a loaded handgun onto school property. The student, who arrived late for classes, appeared to be under the influence of an unknown substance. After being interviewed by the school resource officer, the student stated he had a loaded handgun in his vehicle on the parking lot. The .25 caliber pistol, a knife and drug paraphernalia were recovered from the car. The student was charged with weapons and drug charges.

---

San Diego school officials were alerted to an 11<sup>th</sup> grade student with a loaded gun at the Alternative Learning for Behavior and Attitude. The gun, a .22 caliber pistol, was found in the student's pocket and was loaded with four rounds. The 17 year old has been charged with bringing the gun onto school property and faces administrative school sanctions.

A 17 year old student at Pearl-Cohn High School in Nashville, TN has been arrested for bringing a 9mm pistol to school. The pistol had a fully loaded magazine. The student told authorities he found the weapon on the street and brought it to school. The pistol had been reported stolen in a burglary. He has been charged with bringing the gun onto school grounds and possession of stolen property.



A student at Cy-Creek High School in Houston, TX has been removed from school pending an investigation initiated after a gun was found in his car on the parking lot. The weapon was located during a random sweep of the student parking lot.

---

Following reports from students at Seneca High School in Louisville, KY, a school resource officer removed an unloaded gun in a student's backpack. The student told officials that the gun was for his protection "due to issues outside of the school." He has been charged with bringing the gun onto school property.

A 16 year old student at Brunswick High School in Brunswick, GA has been arrested for making a social media threat to shoot students at the school. The message was sent via "Air Drop" and caused the school to go into lockdown as the incident was investigated. The student has been charged with making threats against a school campus.

---

A 16 year old girl has died after being stabbed twice in the chest in a classroom at Fitzgerald High School in Warren, MI. Another 17 year old female student is being charged with homicide. Police say a dispute erupted between the two girls over a male student purported to be the 17 year old's boyfriend. Prior to the incident the girls were best friends.

---

Information is limited, but two Jim Hill High School students in Jackson, MS have been charged with aggravated assault after a fight on a morning school bus. During the fight, a third student was stabbed

multiple times with a pair of scissors. The student sustained wounds that required hospitalization. In addition to criminal charges, the two students have been administratively disciplined as well.

---

A 14 year old student at East High School in Des Moines, IA has been charged with bringing a handgun and knife to school in his backpack. School authorities were alerted by other students and the student was confronted by the School Resource Officer. The weapons were brought to school in response to some type of on-going dispute. He has been charged with bringing the weapon onto school grounds.

A student at the Blossomwood **Elementary** School in Huntsville, AL brought a handgun to school and was showing to other students in a bathroom. As he handled the weapon it discharged striking him in the hand. The child was not seriously wounded and school authorities indicated the student had no intention of harming anyone. The child's father has since been arrested after it was determined the handgun was his and was in fact stolen. Letroy Cole, Jr. has been charged with possession of the stolen firearm and being a person prohibited from possessing firearms.

---

A student at Vero Beach High School in Vero Beach, FL has been charged with bringing a handgun to school. The 17 year old was reported by fellow students after brandishing the weapon in the school parking lot.

---

Parma, OH police have arrested a 14 year old student at Normandy High School for bringing a handgun to school. After showing off the weapon, the student was reported to school authorities who recovered the gun. No threats were made and the student was taken to a juvenile detention home.

---

A classroom teacher at Saint Bernard Regional Catholic School in White Township, PA noticed an 11 year old was displaying unusual behavior. When she investigated, she found the student as holding a fully loaded handgun. The student's guardian reported the weapon missing.

---



A 9<sup>th</sup> grade student at the Conroe Independent School District in Conroe, TX reportedly brought a handgun to school. The weapon was found after other students notified authorities. The school district, citing privacy, has declined to provide any further information.

---

A student at Pisgah High School in Pisgah, AL has been charged as a juvenile for making a threat against the school. The student is alleged to have posted a picture of a pistol on Snapchat and warned other students not to attend school.

---

A West Ottawa High School student in Ottawa, MI has been arrested for bringing a stolen handgun to school. Other students reported the student had the loaded pistol in his backpack. The weapon was recovered by School Resource Officers. A telephone video of the suspect handling the handgun was recovered from another student.

---

A School Resource Officer received information that a student at McKinley High School in Canton, OH was in possession of a firearm. A search of the student's backpack located the pistol in his backpack. The gun had been reported stolen on the previous night. He has been charged with bringing the gun onto school grounds and possession of stolen property.

---

A teacher at Perryville Elementary School in Perryville, MO went to get a piece of clothing out of the backpack of a 10 year old student. To her surprise, she found an unloaded handgun. The pistol was turned over to the School Resource Officer and the student was referred to juvenile authorities.

---

Ball High School in Galveston, TX was placed in lock down after a student was found to have a .25 caliber handgun in his possession. He has been charged with felony possession of the weapon and held by juvenile authorities.

---

School Resource Officers received information that a 16 year old was in possession of a handgun in his backpack. A student reported the handgun to a Guidance Counselor who notified the officers. The Owasso High School student in Owasso, OK was searched and a loaded .22 caliber mini revolver was found. He has been turned over to juvenile authorities.

---

A nine year old student at Helen Marie Elementary School in Las Vegas, NV has been taken into custody for bringing a .22 caliber handgun to school in his backpack. Authorities were alerted by other students and a search uncovered the weapon. Although the gun was unloaded, the student had ammunition on his person. He has been turned over to juvenile authorities. The District Attorney is considering charges against the student's father for child endangerment.

---

Two female students of Gibbs High School in St. Petersburg, FL became involved in an argument at the school bus stop. The disagreement erupted into a physical altercation. The fight was broken up by neighbors. As 16 year old student boarded the bus, the 15 year old stabbed her once in the back with a knife. She was taken to a local hospital in serious but stable condition. The 15 year old has been charged with assault and possession of a weapon on school property. She has also been charged with assault after threatening the wounded student's mother with a pair of scissors.

The FBI has launched a public awareness campaign after threats have drastically increased in the last year. The #ThinkBeforeYouPost initiative is designed to collaborate with other law enforcement agencies to educate the consequences of making threats to schools and other public places. The FBI concludes it is not a joke to make a threat. It almost 100% likely that you will be caught and face consequences criminally.

## HURRICANE SCAMS

As the East Coast suffers the damage of Hurricane Florence, the scammers are hard at work setting up their fraudulent donation networks to take advantage of those wanting to help their fellow citizens. Search the name of organizations on the internet to see if there are any alerts of fraud posted. Also watch for charities with names that closely resemble those of better known reputable organizations. In addition be careful of unsolicited telephone calls requesting donations. The Federal Trade Commission recommends that you do your due diligence before making any donations. Typically organizations like the American Red Cross are safe bets. Other reputable organizations are generally featured on the major news networks. Two sources to consider are [Charity Navigator](#) and [GuideStar](#), both which list a legitimate charitable organizations. Remember ... these scammers are unscrupulous and they have no intention of forwarding donations to those affected.

## INTERNATIONAL TERRORISM



A threat is being distributed on pro-ISIS social media channels. The picture, which has a New York City background, warns “Soon, we will come to you in your own land” and “Soon God willing.”

Rasheedul Mowla of Brooklyn, NY has been charged by the FBI after traveling to Saudi Arabia to enlist as an ISIS fighter in 2017. He was stopped trying to enter Syria and returned to the United States. When interviewed Mowla claimed he was traveling with friends to celebrate a religious holiday. Subsequent investigation determined otherwise. He has since acknowledged the true purpose of his trip. He admitted he was willing to fire weapons against others and planned to die on behalf of ISIS. He has been charged federally with attempting to provide material support to a terrorist organization.

Al-Qaida has released a 30 minute video with their leader Ayman al-Zawahiri urging his followers to hit America hard, bleeding it to death both militarily and financially until they are forced from “our lands.” Al-Zawahiri prefaces his speech “How do we confront America?” He urged followers to move towards violent jihad. Al-Zawahiri proffers that they have two choices, confront the aggression or accept disgrace.

## TERROR INSPIRED INCIDENTS



Alexander Ciccolo, who also used the name Ali Al Amriki, has been sentenced to 20 years in federal custody for planning a terror attack. The FBI described Ciccolo as a “committed soldier” of ISIS. He planned to construct pressure cooker bombs filled with nails and balls bearings similar to the Boston Marathon bombs. Ciccolo was planning to attack a college campus, but had not chosen his specific target. A search of his apartment revealed firearms and petrol bombs. He plead guilty earlier to attempting to provide support for a terrorist group.

A federal grand jury in Albuquerque, NM has indicted the five Wahhaj occupants of a compound on firearms and conspiracy charges. The indictment charged Jany Leveille, a Haitian immigrant and four other defendants who were charged with conspiracy to provide weapons to an illegal alien. The compound was led by Siraj lbn Wahhaj and acted as a training and firing range for the group to prepare for violent attacks on government, military and financial institutions.



## UNUSUAL INCIDENTS




Jeffrey Metcalf was stopped by troopers in Arizona for a routine traffic violation. During the stop it was discovered that Metcalf had bomb-making materials in his vehicle. Metcalf told troopers he was on the way to dump the materials in a local body of water and that he had live pipe bombs at his home. A search of Metcalf's residence revealed 42 live pipe bombs and sufficient material to construct at least 30 more. Metcalf indicated he built the devices at the direction of his estranged "prepper" wife who feared the collapse of the U.S. Government. In 2008, Metcalf was investigated for making an imitation improvised explosive device while in the U.S. Marine Corps.

He told investigators he built the device to show how easy they were to construct. Metcalf has been charged with multiple counts of manufacturing and possessing explosive devices.



Michael Fry crashed his truck through the front windows of a Dallas television station. After ramming his truck into the building, Fry pulled out a bag prompting a bomb squad investigation. No explosives were found. Fry spread a number of papers around the scene, some of which showed Fry and Roberto Hernandez. Fry was a passenger in Hernandez's car when it rammed a sheriff's car in 2012. Police shot and killed Hernandez. The printouts were covered with rambling handwritings

referencing "high treason" and "witchery." Fry told reporters "they were trying to kill me, and they missed and they killed Roberto Carlos Hernandez. Ever since I've been running for my life and I don't know what to do." Police reported that Fry was in some kind of agitated mental state. He has been charged with a second degree charge of criminal misconduct.



San Diego, CA police have arrested 79 year old Nathan Brogan for shooting a San Diego city employee. The employee had gone to Brogan's home in an attempt to restore water to the residence. Brogan confronted the worker and shot him once with a shotgun. His injuries will require multiple surgeries. A search of Brogan's home revealed an AR-15 rifle with a 200 round drum magazine, 34 rifles, 21 handguns, 4.5 pounds of black powder and 75,000 rounds of ammunition. He is being held on one million dollars bail.



Up to 130 cars were set ablaze at the Kings Plaza Mall parking garage in Brooklyn, NY. Eighteen fire fighters and three civilians were injured in the seven alarm fire. Investigation led to the arrest of Avon Stephens for setting the fire. It's alleged that homeless Stephens was roused from his favorite sleeping location in the parking garage by mall security. He confessed to setting a car on fire as revenge, which quickly spread through the second and third floors of the garage.

## RELIGIOUS INCIDENTS



A Snapchat video has led to the arrest of Kevin Hayes and Thomas Anderson for a serious vandalism incident at the Church of Jesus Christ of Latter-day Saints in Spanish Fork, UT. The two are seen on video in the church making the statement “we just (profanity) up a church.” Damage to the church included ripped hymnals, pictures removed from walls and smashed, fire extinguishers discharged and damage to plumbing fixtures and kitchen appliances. They have been charged with burglary and criminal mischief.

Clint Vance has been charged with vandalism to a place of worship. Vance is alleged to have targeted the Church of Christ in Woodstock, GA on three occasions and also vandalizing the Noonday Baptist Church, the Church of Christ in North Cobb and the Wildwood Baptist Church in Acworth. Vance purportedly spray painted “satanic phrases and obscenities” on the doors of the churches.



The Rutherford County Sheriff’s Department near Nashville, TN has arrested four juveniles for vandalizing the Walnut Grove Missionary Baptist Church. Deputies found that bibles had “KKK” written inside and “we are white and we are watching you, white power” written on the church door. The juveniles are also alleged to overflowed toilets and stolen a laptop computer and a video camera. All have been charged with burglary, theft and vandalism.

## WORKPLACE VIOLENCE

Forty year old Claude Elliott has surrendered to Baton Rouge, LA police after shooting his ex-girlfriend in the parking lot of a public school warehouse. Witnesses told police Elliott chased the victim from her car when she arrived for work and shot at her multiple times. The woman was wounded in the foot. Elliott has been charged with attempted murder and weapons charges.

Javier Cazarez fatally shot five people in Bakersville, CA. The series of shootings occurred when Cazarez and his wife showed up at a local trucking company. After a confrontation inside, the assailant shot a man and then turned the gun on his wife killing her instantly. The shooting was witnessed by another man, who was chased from the business and also fatally wounded. The assailant then went to a nearby home and killed two men. He then hijacked a car occupied by a mother and her child who were able to escape. When confronted by police the assailant died of a self-inflicted gunshot wound. The suspect and his wife were involved in divorce proceedings and their exact connection to the original victim is still being investigated.

Sacramento, CA deputies responded to a customer dispute at a local Pep Boys store in Rancho Cordova, CA. As they arrived, the disgruntled customer, Anton Moore, immediately opened fire, killing Deputy Mark Stasyuk and wounding another. The customer and a bystander were also injured by gunfire. A motive remains unknown.

Police in Madison, WI are searching for a motive for a work-place shooting at WTS Paradigm. Anthony Tong, an employee opened fire with a pistol and wounded four fellow employees. It is reported the suspect had a significant amount of ammunition in his possession. Three of the employees suffered serious wounds and the fourth was only grazed. The suspect was shot and killed after firing on responding police officers.



Twenty six year old Snochia Moseley, a temporary employee at the Rite Aid distribution facility in Perryman, MD, exited her vehicle armed with a .9mm pistol and several magazines. One witness described Moseley as being in a bad mood and looking to pick a fight. Once inside she fatally wounded three co-workers and shot three more, causing what appears to be survivable injuries. Moseley died after turning the gun on herself. Her motive is still unknown at this point.

Co-workers in Glendale, AZ reported that Saul Nevarez came to work and was “acting strangely.” He went into a bathroom where he remained for a long time, prior to coming out talking to himself. He sat down at his workbench for several minutes and then inexplicably stabbed a female co-worker several times in the arm and abdomen with a screwdriver before being tackled by other workmates. The victim is recovering from non-life-threatening injuries and Nevarez has been charged with assault.



## HATE CRIMES



A yet unidentified man was shot and killed by Miami Police and FBI Agents after engaging them in a gun battle near the Miami Airport. The FBI has indicated the shooter, who was armed with an AK-47 rifle, was wanted in connection with a hate crime investigation they were conducting. Sources have said the man is possibly linked to an attack and robbery of a gay man in Miami earlier. The assailant in that case told the victim “all gay men should be dead.” During that incident the victim was pistol whipped and robbed of money and jewelry. Earlier state and federal authorities announced they were searching for Alexander Carballido in relation to that incident. Carballido was released from prison in July after serving time for kidnapping, carjacking with a weapon and assault on a police officer.

Washington, D.C. police are attempting to identify a woman who hurled a brick through the windows of “Check it Enterprises” a LGBTQ community center in Anacostia. Security cameras captured footage of the woman throwing a brick through the front door. She retrieved the brick and broke a second pane of glass. Witnesses indicate the woman was yelling anti-gay slurs during the incident.



Albany, NY police officers found an unconscious man suffering from head and face wounds. Witnesses identified Hubert Dabbs as the man who beat and stomped the victim. The victim sustained critical non-life threatening injuries, to include the loss of an ear. Dabbs is believed to have attacked the victim for being gay. He has been charged with attempted murder with enhanced hate crime agitators.



New York police have charged Jem Ibrahimov with felony hate crimes and vandalism. Ibrahimov was caught in the act of painting racist comments on an FDNY ambulance. Similar swastikas and other graffiti were found on a fire station and several other locations in the area.



The graffiti spree occurred over several days. Ibrahimov, an artist, claims his actions were art work and not hateful.




## DRUG AWARENESS

The Maryland Attorney General’s Office is seeking \$20 million dollars in various penalties from Arizona based Insys Therapeutics for allegedly violating consumer protection laws thousands of times by engaging in a deceptive scheme to buy the help of doctors and deceive insurance companies to boost sales. Insys Therapeutics is the manufacturer of a powerful fentanyl spray. The Attorney General claims doctors were compensated thousands of dollars as rewards for writing prescriptions to treat conditions other than the drug’s approved purpose of managing pain for cancer patients. Insys Therapeutics is alleged to have made more than \$20 million dollars in revenue from 3,000 prescriptions written in Maryland according to the Statement of Charges. Insys Therapeutics has been the subject of a long-standing federal investigation. As part of that action, Insys Therapeutics has agreed to pay \$150 million dollars to settle federal allegations.

Louise Edwards of Upper Marlboro, MD has been sentenced to ten years of federal incarceration for writing or filling false prescriptions for 30 milligram oxycodone pills. Edwards, who worked as a medical assistant in a Virginia doctor’s office, admitted to stealing blank prescription pads and using the medical record system she had access to cover her scheme. She admitted to facilitating at least 353 prescriptions and fraudulently obtaining 42,360 pills.



## SCAMS AND HACKS


The Federal Trade Commission (FTC) announced it has brought charges against three sellers of bogus documents. The complaints allege Innovative Paycheck Solutions, Integrated Flight Solutions and Abstract United sold fraudulent documents used for identity and theft schemes via their websites. The bogus

documents included pay stubs, banks statements, tax forms and medical documents. In schemes such as these, it allows thieves who acquire your personal data to produce documents in your name to obtain credit, sign leases and file fraudulent tax returns. When the schemers don't pay or comply with contracts, it is your credit that suffers.

### Merrill - Ledford Fraud Scheme



Federal authorities have indicted Kevin Merrill of Towson, MD and two Texas men for being involved in one of the largest Ponzi schemes ever uncovered in the Maryland area. The scheme allegedly defrauded investors out of \$364 million. The indictment charges that the men pretended to be making money for investors by collecting debt payments and selling the debts to debt buyers. Instead they were paying investors' money received from new investors. The majority of the victims, including doctors, business owners, retirees, professional athletes, talent agents, accountants, restaurateurs and construction contractors, were from the Baltimore and Northern Virginia areas. As part of the scheme the suspects created two fictitious companies, Santander Consumer USA and National Loan Exchange, where victims sent their money. ## HOME SECURITY TIPS

Most people only worry about nighttime security, although most home burglaries occur during the daytime when people are at work or school. It is just as important to take precautions during the daytime to ensure your home remains secure and safe. You can't be too careful when it comes to protecting your family and belongings. Consider the following:



- Walk around the exterior of your home. Survey your property through the eyes of a burglar. Are there hiding places? Does shrubbery provide a shield from view? Have you considered planting thorny shrubs under windows to make attempted entry a little more painful?
- Keep fences, gates and garage doors closed and locked.
- Install motion detector lighting on the outside especially at entrance points and blind spots.
- Keep your blinds closed. Don't allow window shopping.
- Consider adding privacy film or decorative glass to distort a view of the inside of your home.
- Consider installing a security alarm and camera system. Most now have remote connectivity.
- Security signs warning of an alarm or camera are often burglary deterrents.
- Put away expensive items like bicycles and grills. Don't leave them out for targeting by thieves.
- Install large reflective numbers on your house and mailbox.
- Secure valuables in a home safe or lockbox.
- One man's trash is another man's treasure. Purchase a shredder for no longer needed documents and financial statements.
- Don't hide keys outside.
- Have two locks on your doors. One lock should be a "dead-bolt."
- Make sure all door hinges are installed on the inside.
- Put a bar in a sliding door and windows.
- Keep your garage door closed. Do not leave your garage door opener in a vehicle in the driveway when you are not home.
- Put timers on lights to give the home an occupied look when no one is home at night.
- Leave a radio or television on.
- Going on vacation? Don't advertise your trip on social media.
- Stop mail and newspaper service while gone.
- Form a neighborhood watch program.

- Photograph all valuables and record serial numbers. Keep purchase receipts and warranty paperwork secured.
- Consider inscribed your “driver’s license number” on the bottom of items. Never use your “social security number.”


